fat horses, serious competition horses, feeding of mares and youngstock. Contact the office beforehand and we will get Lorna to contact you.

Horse Passports

For any of you who are not already aware a new horse passport order came into force across the UK on 1st July 2009. This replaces the previous horse passport order. All horses must now have passports. Any horse that doesn't currently have a passport must be microchipped by a vet before the passport can be applied for. There is now no need to complete a silhouette to comply with the legislation but many breed societies still need an ID card to be filled in. For a copy of the legislation visit

The legislation also strengthens the requirement for us to examine passports before treating an animal. Please make sure that your horse's passport is available every time we are asked to see a horse. Failure to show us the passport will mean that we cannot administer certain drugs, even in emergency situations.

This will effectively mean that we cannot dispense any medicines or give a prescription for any horse without seeing the horse and the passport first!

You should apply for a passport for all foals before they reach six months of age. If a passport is not applied for before six months of age then the horse still needs a passport but any application for a horse older than 6 months will now automatically exclude that animal from the food chain.

The passport should remain on the premises where the horse is kept and no horses may be travelled without a passport except foals under 6 months of age travelling with their dams. It is now a legal requirement to update the ownership of the horse with the relevant passport issuing organisation (PIO) to inform them of any change of ownership within 30 days of the change, and also to return the passport to the PIO within 30 days of the death of any horse.

Although we have always done it anyway, it is now also a legal requirement to record all vaccinations on the passport.

Sorry if this is all a bit boring but it is the law and like it or not, we will have to comply with it. Please remember to have your passports available whenever we are required to treat your horse.
