I wish to book my mare in to Dykehead Farm Stud for the 2025 season to be artificially inseminated with semen from the stallion named above. I confirm I have read and understand exactly what procedures are and are not covered by the fixed fee scheme. I acknowledge that I will pay all other fees for livery and care of the horse whilst at Dykehead Farm Stud, and other costs relating to the purchase, transport and storage of semen. **I am aware that all outstanding fees must be paid before the mare leaves the stud.**

I acknowledge that breeding horses involves an element of risk for the mare and I am prepared to take that risk. I understand that it is my responsibility to ensure the mare is adequately insured to cover all risks whilst she is at Dykehead. Should the mare need referral to a specialist centre for any reason I do/do not authorise this in an emergency if I cannot be contacted, and I will pay all fees related to this.

I confirm that I wish Dukes Equine Vets Limited to have responsibility for the veterinary care of my horse during the period that the horse is at Dykehead Farm, and that should the horse need any treatment for any other illness, injury or routine healthcare during her stay at Dykehead Farm I confirm that I authorise Dukes Equine Vets Limited to carry this out as appropriate.

Whilst every care will be taken with semen stored by Dukes Equine Vets Limited, I understand that all semen stored by Dukes Equine Vets Limited is at my own risk. I must take out my own insurance for the semen during storage if I require it.
